## **FLOODING**

Following the recent flooding scare in the village the Parish Council has produced 'A Helpful Guide' leaflet which will shortly be distributed to those residents living in an area that is at risk from flooding – whether it be from the village beck or from surface water.

The leaflet contains useful advice and information together with a list of relevant third parties who could be contacted by residents affected by flood water. It should be noted that the PC will endeavour to come to the aid of any elderly, vulnerable or infirm residents who require help. This assistance will include the provision of sandbags when necessary and their subsequent removal once the threat of flooding has receded. However, we must point out that, for most property owners in flood risk locations the responsibility to take appropriate action to protect your property from inundation rests with yourselves.

The PC has also undertaken a stock take of the contents of both of its emergency containers and will shortly be replenishing their sandbag supplies in both.

# **DRAINAGE ISSUES**

During the recent heavy rains, the Parish Council has been regularly monitoring the performance of the village drainage system and reporting any issues to the Severn Trent Water call centre.

We have been advised by STW that we need to do this for them to build up a record of the continuing issues. This will help them build a business case for undertaking any necessary improvement works. Whilst the PC would hope to catch all incidents (a typical example of which is shown below) could we ask local residents to take pictures of similar issues and either report them directly to the STW call centre on 0800 783 4444 or pass on any images to the PC giving details of date, time and location and we will forward the information for you. We hope we can rely on your help in this matter – the more complaints/ reports STW receive the better the chance of getting something done!



# **JAMES NAISH UPDATE**

#### ARTS AND HERITAGE GRANT, 2024

Last year, Bassetlaw received £3.4m from the Government as part of the UK Shared Prosperity Fund. One of the initiatives within this is to support "local arts, cultural, heritage and creative activities". Grant funding to do this is now available for two types of groups:

- If you are an unconstituted group, you can apply for between £500 and £1000 and should request the C&P E6 Small Grant Application Form. You will require a constituted organisation to support your application.
- If you are a constituted group, you can apply for up to £5000 and should request the C&P E6 Grant Funding Application Form.

We have now set up a dedicated working group to canvas further opinions as to what developments parishioners would like to see. It is our intention to place additional relevant consultation articles on both our PC website and on or PC Facebook page for individuals to put forward their ideas. For those residents without access to

our website or Facebook page you can contact any councillor to have your say. Please bear in mind when formulating your ideas that informed by BDC that no planning permission will be granted for any permanent building works in that location! Once all the proposals have been received, they will be reviewed for suitability, practicality, and impact on local neighbours. A full list of all suggestions received will be drawn up and published together with confirmation of which have

been discounted and the reasons why.

Following this publication a further consultation is planned to seek opinion on the short-listed ideas and hopefully identify proposals for the way forward.

will be generated through council tax locally, known as faced by many the 'policing precept'. Police officer numbers are now at their highest level in over a decade in Nottinghamshire, however inflationary costs and the rising scale and complexity of policing demand continue about three minutes. to place increasing pressure on our services. This is despite the year on year efficiency savings that we continue to deliver.

I know that policing, crime reduction and community safety are important issues to the residents of Nottinghamshire, but I am also acutely aware of the

financial pressures being Nottinahamshire households.

To help me get the balance right, I hope you might be willing to take part in the consultation. It should take I thank you in advance for your support in our work to prevent and respond to crime, support victims and keep Nottinghamshire Safe.


